

**RESOLUTION CONCERNING TAX EXEMPTIONS FOR 2024**

WHEREAS, the laws of the State of Texas provide, under certain circumstances, for the exemption of a portion of the value of residence homesteads from ad valorem taxation; and

WHEREAS, the Board of Directors of Harris County Municipal Utility District No. 537 of Harris County, Texas (the "District"), desires to implement the following residence homestead exemptions; Now, therefore;

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 537 OF HARRIS COUNTY, TEXAS THAT:

Section 1: The Board of Directors of the District has considered the matter and has determined not to adopt an exemption from ad valorem of the appraised value of residence homesteads of individuals who are disabled or are sixty-five years of age or older, as authorized by Section 11.13 of the Property Tax Code, as amended.

Section 2: The Board of Directors has considered the matter and has determined (i) not to adopt a general residential homestead exemption as authorized by Article 8, Section 1-b(e), Texas Constitution and Section 11.13 (n) of the Texas Property Tax Code, (ii) not to adopt a tax exemption for charitable organizations, and (iii) to adopt a tax exemption for travel trailers.

Section 3: This Resolution constitutes official action by the Board of Directors of the District concerning the foregoing tax exemptions.
