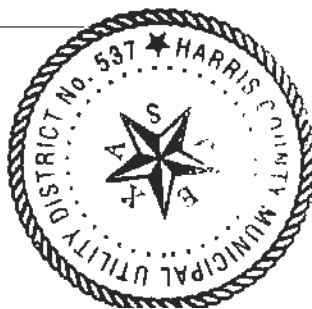

WHEREAS, at an election held on November 4, 2014, the Board of Directors of Harris County Municipal Utility District No. 537 (the "District") was authorized to levy a maintenance and operations tax by the voters of the District; and

WHEREAS, the District may levy a tax on all taxable property in the District to provide for payment of expenses as set out in Section 49.107, Texas Water Code; and

WHEREAS, the tax rolls for the tax year of 2020 have been prepared and certified by the Harris County Appraisal District; and

WHEREAS, based on said appraisal roll, the Financial Advisor for the District has made a recommendation as to what the tax rate should be.

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 537 THAT:

Section 1: The total tax rate for the year 2020 shall be \$0.50 per one hundred dollars (\$100) of assessed valuation; which tax shall be allocated \$0.23 per \$100 assessed valuation for water, sewer, and drainage debt service purposes; \$0.06 per \$100 assessed valuation for road debt service purposes; and \$0.21 per \$100 assessed valuation for maintenance and operation purposes. The District's Tax Assessor/Collector shall take all steps necessary and authorized by law to collect taxes as owed pursuant to this Order. Said taxes shall be levied, assessed and collected at the rate of \$0.50 per \$100 of assessed valuation for 2020 as provided for in Chapter 49, Texas Water Code, and all other applicable laws. The revenues from the debt service portion of such ad valorem tax shall be for the 2020 calendar year. The revenues from the operation/maintenance portion of such ad valorem tax shall be for the fiscal year ending May 31, 2021.

Section 2: The attorney for the District is directed to file this Order Setting 2020 Tax Rate with the District's Tax Assessor/Collector.

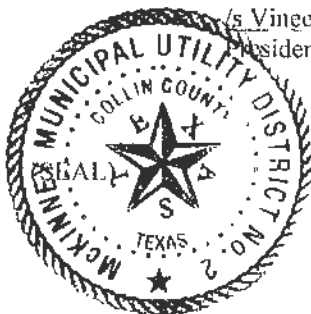
Section 3: The President or Vice President is authorized to do all things necessary for execution of this Order; and the President or Vice President is further authorized to execute, and the Secretary or any Assistant Secretary to attest, this Order on behalf of the Board of Directors.

Section 4: This Order shall be effective from and after its adoption.
